Clethodim is a selective post-emergence herbicide, rapidly absorbed and readily translocated from treated foliage to the root system and growing parts of the plant. It can control of annual and perennial grasses in a wide range of broad-leaved crops.

Direction for use

Post-emergence control of annual and perennial grasses, at 60-240g/ha, in a wide range of broad-leaved crops (including such field crops as soya beans, cotton, flax, sunflowers, alfalfa, peanuts, oilseed rape, sugar beet, tobacco, and potatoes), vegetable crops, trees and vines.

Do not apply this product more than three times per crop season.

Compatibility:

Incompatibility with: strong oxidising agents.

Principle use

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

Environment hazards

Clethodim is highly toxic to honeybees if used as a foliar application, especially during flowering, but is not considered a hazard to bees when used as a seed treatment.

Personal protective equipment

Applicators and other handlers must wear: long-sleeved shirt and long pants, chemical resistant gloves, shoes plus socks, and protective

eyewear. Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate.

Storage and Disposal

Store the product in original container only. Store unused product in a cool, ventilated, dry locked area. Keep away from heat, sparks and flames. Never transfer this product to another container. Dispose of in an approved manner (consult local authority) only as a last resort. Otherwise, apply according to label instructions. Consult label and Directions for Use.

First aid:

Inhalation: Remove to fresh air.

In eyes: Hold eyes open and rinse slowly and gently with water for 15-20 minutes.

Ingestion: Do not induce vomiting. Give large quantities of water or milk. Seek medical attention.

On skin: Wash with soap and water. Remove contaminated clothing.
